## **Conditions of participation**

- 1. Participants will receive a fixed contribution towards their travel and accommodation expenses and will be asked to book their own travel after receiving confirmation from ERA. The condition for payment of this contribution is to sign all attendance sheets at the event. No supporting documents are needed. The amount of the contribution will be determined by the EU unit cost calculation guidelines, which are based on the distance from the participant's place of work to the seminar location and will not take account of the participant's actual travel costs.
